Four Day Threes:	Children must be three by August 31, 2017
Five Day Threes:	Children must be three by August 31, 2017
Four Day Pre-K:	Children must be four by August 31, 2017
Five Day Pre-K:	Children must be four by August 31, 2017
Transitional K:	Children must be five by August 31, 2017
Kindergarten:	Children must be five by August 31, 2017
Two Day Twos: (Jan. 2018)	Children must be two by December 31, 2017

Registration forms for present Day School students will be accepted in the Day School office immediately. Forms for children not presently enrolled in the school will be accepted beginning January 4, 2017. We have a **Private Academic School License that requires children enrolled in our 3 year old program through Kindergarten to be toilet trained. Our 2 year old program does not fall under this license; toilet training is not a requirement for these children.**

Please note that the \$85 application fee is non-refundable. This fee covers the cost of mailings, book bags, insurance, special programs, and snacks. Applications for the January 2018 class should be returned without the application fee. It will be collected in November 2017. Toddler enrollment, the parent/child program, is on a separate card which may be picked up in the office.
